Can we help your organization?

The CIRCLLe Fund, a fund within the Rush County Community Foundation, has been created as a place where women can combine their resources to influence and impact Rush County life. Our competitive grants are investments in the community that enable charitable and non-profit organizations to provide effective programs or projects that respond to the needs of people in Rush County.

Grant Priorities: The CIRCLLe is interested in innovative programs or projects that are responsive to community needs, partnerships, and collaborative efforts.

Eligibility: Organizations must be located in or provide service to residents within Rush County, Indiana. Generally grants will be awarded to tax-exempt organizations classified as 501(c)(3) charities.

Restrictions: Grants will not be made for operating expenses, annual fundraising drives, salaries, travel expenses, existing obligations, debt reduction, building campaigns, services which are primarily supported by tax dollars or are the responsibility of a public agency, advocacy or political purposes, religious or sectarian purposes, loans or endowments.

Grant Application Deadline: May 15, 2020, see application for details.

Please fill out the application completely. Incomplete applications may result in your grant application being declined.

Grant Amount: Our intent is to award one grant for \$16,500 in order to have the greatest impact on our community.
